

## SUNKIST/SQUIRT SPIN THE WHEEL GAME

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO PLAY OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- PROMOTION DESCRIPTION:** The **Sunkist/Squirt Spin the Wheel Game** (“**Game**”) begins at 12:00:00 AM (ET) on 7/1/24 and ends at 11:59:59 PM (ET) on 9/1/24 (“**Promotion Period**”).
